- Privacy Issues became concerning



% of online adults who use the following social media websites, by year



Fake Steve Joel Twitter Account **STUDENT DISCIPLINE LAW** §79-267: Schools may discipline students for conduct that "occurs on school grounds, in a vehicle \*\*\* being used for a school purpose \*\*\* or at a school-sponsored activity or athletic event."

## Oregon court rules student's offcampus online speech could not be regulated by school district

Burge v. Colton Sch. Dist. 53, No. 14-605 (D.Or. Apr. 17, 2015)

Abstract: Federal Court in Oregon has ruled that a SD violated a

#### student's First Amendment free speech rights by

disciplining him for off-campus online speech. The court found that the school district was not justified in suspending the student because his online comments did not cause substantial interference to school operations as required under *Tinker v. Des Moines Indep. Cmty. Sch. Dist.*, 393 U.S. 503 (1969).




# "The school district's distribution of **Gender Spectrum's materials**

On its face, federal law does not list sexual orientation or trans-gender status as protected categories. Some states or cities have passed their own laws offering such protections, leaving a patchwork of laws across the country.

For this reason, many employers have delayed adding to their handbook's list of protected classifications for either political reasons or to avoid arguably granting more protection than required in those local jurisdictions without expanded coverage.

A communications mixup about whether or not the Nebraska School Activities Association established a policy for transgendered students to be allowed to play on the sports team they identify with drew the issue front and center in the state.

Earlier this year NSAA executive director Rhonda Blanford Green was quoted in the media as saying the NSAA did adopt a policy in December 2012. Later Blanford Green said the policy was discussed at the December board meeting, but no vote was taken. As one attendee stated: "What I heard was that the NSAA will not handle policy [related to GLBT students]," he said. "Their recommendation is for individual districts and school boards to contact their legal representatives."


- Critics lurk in shadows anonymously seeking to inflict damage
